OPENING AND CANVASSING OF MAY 6, 2017 ELECTION RETURNS

Discussion and Possible Action on an Order Canvassing the Returns and Declaring the Results of the May 6, 2017 Bond Election and Approving any Other Matters in Connection Therewith

The Board of Trustees adopted the order canvassing the returns of the May 6, 2017 Bond Election, conducted by the Bexar County Elections Administration Department jointly with elections of other political subdivisions in Bexar County, Texas; declares that the majority of the resident, qualified voters of the College District voted FOR the Proposition on the authorization and issuance of \$450,000,000 in general obligation bonds; and approves any other matters in connection therewith.

CHAIR'S REPORT

Discussion and Possible Action on Board Letter of Support for Sandra T. Mora to be nominated for the ACCT Board Professional Staff Award

The Board of Trustees agreed to issue the letter of support provided in the board packet to nominate Ms. Mora for this award.

Discussion on Perceptions of the Alamo Colleges District by the Community for Bond Election

Dr. Katz shared some results from the pre-bond election survey of the community. She said the Alamo Colleges District polled a 3:1 positive image rating in Bexar County overall. 69% of respondents said they knew someone who had benefited by attending one of our colleges.

CHANCELLOR'S REPORT

Monthly Report on Alamo Colleges Regional Centers, Dr. Federico Zaragoza Mr. Chester Jenke, Alamo Colleges – CTTC Region Center Manager was one of the featured presenters at the 2017 National Farmworker Conference held in San Antonio. Mr. Jenke's participated on a panel featuring effective rural workforce training strategies. His presentation on the CTTC center model was later referenced by Texas Workforce Commissioner, Julian Alvarez as a highly effective and deployable higher education and economic development model. Commissioner Alvarez stated that regional centers such as the CTTC are "new" models that can make higher education and job training opportunities accessible to rural communities.

The Alamo Colleges – Greater Kerrville Center collaborated with the Kerrville ISD to provide (non-dual credit) a continuing education – Certified Nurse Assistant training programs for a cohort of 10 Kerrville ISD CTE- students during the Spring 2017 semester. Of the 10 KISD students, 9 successfully completed the Certified Nurse Aid (CNA) course. These students earned CEUs and the high school credit necessary to complete the CNA Certificate of Completion and to meet their high school graduation requirements. Moreover, these students are now eligible to pursue the SPC - CNA to LVN career pathway.

The Alamo Colleges – CTTC Advisory Committee met with the Alamo Academies Board to avoid closure of the Alamo Manufacturing Academy at CTTC due to declining enrollment and insufficient industry internship commitments. Because of the candid discussions, a corrective action plan was codified that included commitments from the Seguin Chamber of Commerce and the New Braunfels Chamber of Commerce to provide the necessary internships; recruitment of the required junior cohort of 12-15 students; and commitment to work with SPC-SWC manufacturing program to upgrade equipment and to assist in faculty recruitment efforts. This situation reflects the collaborative win-win problem solving nature of the Regional Center model.

The Greater Kerrville Center offered the first IBEST "open enrollment" Child Development Associate course in Spring 17. The open enrollment format allows

IBEST grant students as well as community residents to enroll in the courses. To date three students have completed their certifications. Two students were IBEST and one was from the community at large. The students were awarded their certificates during a celebration dinner in their honor.

The New Braunfels Foundation has committed \$30K to support CTE faculty to participate in industry externships. The grants will provide funds to pay substitutes and to allow for time release so that CTE faculty can spend time immersed in 21st century business environments. Industry partners have also agreed to allow the faculty to video processes within their companies so that videos can be used in the classroom. In addition, participating companies will provide CTE faculty with an opportunity to engage plant engineers in project based learning activities including classroom presentations.

The Alamo Colleges Regional Centers are helping grow dual credit enrollments for all the Alamo Colleges by facilitating dual credit connections in their respective communities. During the past thirty days, the Greater Kerrville Center provided testing services, TSI exams, to 211 potential dual credit students. CTTC staff tested and additional 196 students during the same one month period.

The Alamo Colleges Greater Kerrville Center will be adding a healthcare career pathway in the new CTE Building being renovated as part of the \$500,000 Neil Griffin building fund donation. Health Care is the largest industry cluster in the region1.

AUDIT, BUDGET AND FINANCE - Roberto Zárate, Chair

Discussion and Possible Action on FY18 Compensation Adjustments for Faculty, Staff and Administrators

The Trustees approved compensation adjustments effective January 1, 2018 for full-time regular faculty, adjunct and CE faculty, full-time and part-time/temporary staff and administrators. To maintain the College District's ability to recruit and retain excellent employee talent in support of the Student Success mission, compensation adjustments are needed. The FY 2018 operating budget will be built based on the compensation funding model. The recommended adjustments are designed to maintain faculty compensation at the adopted "threeness" target-level among our large college peer group and to move staff and administrator compensation to an equally competitive position.

Discussion and Possible Action on the Annual Debt Management Plan for FY 2018

The Board approved the recommendations as presented in the FY 2018 Debt

Management Plan. The Chancellor or his designee is directed to authorize the

District's outside consultants to prepare any documents that may be necessary
for Board approval.

Discussion and Possible Action on Funding Structured Parking Identified in the Master Plan for the District Support Operations (DSO) Administrative Complex

The Trustees approved the plan to fund structured parking for the DSO Administrative Complex identified in the master plan. The Chancellor or his designee is instructed to proceed with the required documents for this action.

BUILDING, GROUNDS & SITES SELECTION - Joe Alderete, Chair Discussion and Possible Action on the Purchase of Construction Services for the Structured Parking for the Alamo Colleges District Support Operations (DSO) Administrative Complex

The Board awarded the contract to Skanska USA Building, Inc. providing for the purchase of Construction Services for the Structured Parking for the District Support Operations (DSO) Administrative Complex in the amount of \$3 million as requested by the office for the Associate Vice Chancellor of Facilities Operations and Construction Management.

Discussion and Possible Action on the Purchase of Facilities Support Services

The Trustees awarded the contracts to the proposals submitted by the vendors
for the purchase of Facilities Support Services in the estimated annual amount of
\$7.9 million as requested by the office for the Associate Vice Chancellor of
Facilities Operation and Construction Management. The scope of work includes
providing all management, labor, material, equipment, and related fees for the
provision of building cleaning and maintenance services (Custodial Services),
landscaping and grounds maintenance services (Grounds Services); and
services in the areas of: plumbing, irrigation technical support, carpentry,
electrical HVAC, painting and drywall, general maintenance, construction
inspector, project management, and master professional engineer HVAC support
(Staff Support Services). The Custodial Services include emptying recycle waste
in compactors and event setups/teardowns.

PERSONNEL

Discussion and Possible Action on Appointment of Full Time Faculty

The Board approved the appointment of 4 Full Time Faculty submitted by the

College Presidents for the 2017-2018 academic year. Further Board action will

not be required for these persons to teach in the indicated disciplines.

Discussion and Possible Action on Renewal of Certain Administrative Contracts Including but not Limited to Presidents and Vice Chancellors

The Trustees approved and authorized the Chancellor to renew 2017 - 2018 administrative contract agreements for the positions presented to meet the operational needs of the College District.
